You must tell us the name of your school and provide us with your name, grade, age and which contest you are submitting for.

OFFICIAL CONTEST RULES AND GUIDELINES

1. NO PURCHASE NECESSARY TO ENTER OR WIN.

This contest is designed to give students at an accredited Riverside County middle school and high school the chance to submit entries for a chance to win free tickets to Fantasia Comic Con. The winners names and school will be announced 2 weeks before the show on the Fantasia Comic Con media outlets, including but not limited to, the official Fantasia Comic Con website (<http://fantasiacon.com/>), Facebook & Twitter.

2. TIMELINE.

By participating in this contest, entrants agree to be bound by the official terms and conditions. The contest submission period begins January 31, 2018 at 12:01 AM PST and ends March 30, 2018 at 11:59 PM PST.

The contest judging period begins March 31, 2018 and ends April 29, 2018. The notification period for prizewinners begins April 30, 2018 and ends May 5, 2017. All prize winners will be notified through the original email used to send their contest submission. Winners who do not respond within the designated time frame of one week from the original email date will forfeit their prizes to the next eligible winner.

3. JUDGING

Winning entries are selected by the Fantasia Comic Con judges. The entries will be judged on creativity, style, originality and/or resemblance to the source material. The winners will be notified via submission emails between April 30, 2017 and May 5, 2018.

4. PRIZES REDEMPTION

The prize winner(s) will receive is free admittance for the winner and one parent to Fantasia Comic Con Friday, May 12 and Saturday, May 13, 2018. The winners will have one week from the notification email's date to accept the prize. In the event that the winner does not accept the prize or respond in the time allotted the prize will be given to the next eligible winner. There will be one (1) winner from each category for each eligible school.

TERMS AND CONDITIONS

1. ENTRY REQUIREMENTS
